4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Remove from exposure area to fresh air. Treat symptomatically and supportively. If any symptoms appear, get medical attention. Skin contact: Rinse affected area with large amounts of water until no evidence of product remains. Discontinue exposure. Get medical attention if irritation persists.

Eye contact: Immediately rinse eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention if pain or irritation develops.

Most important symptoms and effects, both acute and delayed

After eye contact: Moderate to strong irritation of the eyes (redness, swelling, burning, watering eyes), the occurrence of these symptoms may be delayed. After skin contact: Moderate to strong irritation of the skin (redness, swelling, burning), severe burns also possible.
