There is a danger of aspiration into the lungs during vomiting. Aspiration can result in severe lung damage or death.

#### Chronic Exposure Effects:

Reports have associated repeated and prolonged overexposure to solvents with neurological and other physiological damage. Intentional misuse by deliberately concentrating and inhaling this material may be harmful or fatal. Prolonged or repeated contact may cause dermatitis. Clean up:

# 7. Handling and Storage

#### **Precautions To Be Taken in Handling**

#### **Precautions To Be Taken in Storing**
