GENERAL INFORMATION

PIERCE is a unique blend of highly refined and modified spray oil and superior nonionic surfactants. PIERCE's unique chemistry allows for superior wetting and absorption of those pesticides or products which labels recommend the addition of a spray adjuvant to improve coverage. The addition of PIERCE to a spray tank solution will improve a spray application by physically modifying the deposition and wetting characteristics of the spray solution, the result being a more uniform spray deposit. This product cannot be used for aquatic applications. The use of PIERCE can increase pesticidal activity where the following factors occur, but is not limited to:

- 1. When used in areas of the country with low relative humidity and high temperatures.
- 2. When target species are larger than label recommendations at time of application.

FIRST AID

If Inhaled: Remove to fresh air, treat symptomatically. Seek medical attention if irritation develops.

If Swallowed: Rinse out mouth and drink 2 glasses of water. DO NOT INDUCE VOMITING. Seek immediate medical attention.

If on Skin: Wash with soap and water. Seek medical attention if irritation persists.

If in Eyes: Immediately flush with water for 15-20 minutes. Seek medical attention.

DIRECTIONS FOR USE

Use **PIERCE** in spray mixture at a rate of 1 1/2 to 2 pints per acre. Higher rates may be required on hard to control weeds or weeds which are under stress.

NOTE: The application rates on this label are based on pesticide labels which recommend the use of a methylated seed oil or nonionic surfactant. Use the rate recommended on the pesticide label. A compatibility test is recommended prior to use.

MIXING

Prior to pesticide application, clean mixing and application equipment according to pesticide label directions. To minimize foaming fill spray tank 2/3 or 3/4 full of water. If foaming is anticipated, the addition of an antifoaming agent should be added before pesticides, nutrients, or PIERCE. Add pesticides and/or fertilizers as directed by label or in the following sequence: 1) Micronutrients and fertilizers, 2) Dry flowables and dispersible granules, 3) Flowables, 4) Water soluble pesticides, 5) Emulsifiable concentrates. Continue agitation and add PIERCE. After the addition of PIERCE, reduce agitation and allow to mix for 1 to 2 minutes. Continue filling tank while under minimal agitation. NOTE: For optimum results, spray mixes containing PIERCE should be applied within 36 hours.

CONTAINER DISPOSAL

Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. To contact your state and local ACRC recycler visit the ACRC web page at www.acrecycle.org. Decontaminated containers may also be disposed of in a sanitary landfill.
